The Port of Virginia's Maritime Incident Response Team is delighted to present the 33rd Annual Robert E. Rumens Hampton Roads Marine Firefighting School, taking place May 12th–17th, 2025. This six-day training program offers a comprehensive mix of classroom sessions, hands-on firefighting drills, vessel tours, and exercises designed to meet NFPA standards. Beyond the exceptional training, attendees will have numerous opportunities to network with industry professionals.

Led by experienced instructors from the Port of Virginia, the US Coast Guard, TMSA and other public safety agencies, this program is specifically tailored to equip responders with the knowledge and skills necessary to manage maritime emergencies effectively.

Training Details

The school will be held at the Norfolk Fire Rescue Training Center, 7120 Granby St., Norfolk, VA 23505. Upon completion, participants will receive a Certificate of Attendance from the Virginia Port Authority.

To ensure an optimal learning experience, class size is limited to **100 participants**, with a cap of **four (4)** attendees per agency.

Note: Attendees are required to provide their own SCBA with cylinder and face piece. Additional face pieces will not be provided due to safety and resource constraints. SCBA units may be shipped to Norfolk, VA, via UPS or FedEx. Please confirm the recipient's ability to receive your shipment before sending.





Identification Requirements

All attendees must carry a government-issued photo ID (Fire Dept. or Agency ID preferred) each day of the event to access waterfront facilities.
